**Attention debenture holders of

The debenture holders are being updated about the proceedings under Corporate Insolvency Resolution Process (CIRP) under Insolvency and Bankruptcy Code, 2016 (IBC) initiated against D S Kulkarni Developers Ltd. (DSKDL), through emails registered with Registrar & Transfer Agents (RTA) viz. M/s Link Intime India Pvt. Ltd., as well as on websites of Catalyst ( [www.catalysttrustee.com](http://www.catalysttrustee.com) ) and Resolution Professional of DSKDL ( [www.dskcirp.com](http://www.dskcirp.com) ).

As per provisions of IBC, the disclosures of the details of CIRP proceedings are restricted to only financial creditors, including debenture holders. The same is made available to them, upon execution of 'Non-Disclosure Agreement'. However, for the sake of convenience of debenture holders, an arrangement of Virtual Data Room (VDR) is made. The resolution plans submitted by Resolution Applicants are placed on VDR, which can be accessed by debenture holders.

The communication for e-voting on resolution plans received, will be sent shortly only at e-mail ID registered with RTA. It is observed that despite repeated requests, still some debenture holders have not noted / updated their mail IDs with RTA. Such debenture holders, particularly those holding physical debentures, are requested to take immediate step for updating of their mail ID with RTA. They should send by e-mail, an application, self-attested PAN, copy of debenture certificate to a Special Cell created for purpose by RTA.
